of the passage between Orion and McBlair Shoals, eastern entrance to Nantucket Sound, shows that there are numerous spots heretofore uncharted, with 34 to 5 fathoms water on them, while a shoal of small extent, with 18 feet water on it, lies with Great Round Shoal Light-vessel, bearing W. 3 S., distant about 6_{10}^{1} miles, or in approximately lat. 41° 26' 20" N., long. 69° 46' 50" W. Between this shoal and Orion Shoal Buoy the spots above mentioned generally lie.

NOTE.—A depth of not less than seven fathoms may be carried by passing just northward of McBlair Shoal, keeping Great Round Shoal Lightvessel on a W. 4 N. bearing. [Variation 11° Westerly in 1892.]
