THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 28th September, 1892, from Her Majesty's Representative at San Salvador, enclosing the following Translation of a Quarantine Notice, issued by the San Salvador Authorities :--

Decrees :

All vessels proceeding from Europe or from any such countries infected by the above-mentioned pestilence (epidemic) are declared interdicted unless the Committee of Health of the respective ports should have conferred on them a certified clean bill of health.

All correspondence proceeding from those places already indicated shall be fumigated carefully and properly during the space of twenty-four hours on reception at the ports, such fumigation being obligatory even should the vessel carrying the correspondence have received the clean bill of health already mentioned in a former number. In like manner all cargo shall be disinfected on disembarkment.

Any such Captain of a vessel under interdict found breaking the said interdict will be liable to a free of five hundred to one thousand dollars, according to Article 297 of the Law of Navigation and Marine.

Should the interdict be broken by any other person such person shall be punished in a fine of one hundred to five hundred dollars.
