

Civil Service Commission, November 18, 1892.

THE Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz. :—

SPECIAL REGULATIONS (supplementary to the General Regulations issued 8th April, 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the situation of Clerk of the First Division in the Legacy Duty Office of the Inland Revenue Department.

N.B.—*These Regulations are liable to alterations for future Examinations.*

I. The limits of age for this situation are 21 and 25, and Candidates must be of the prescribed age on the first day of the examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature. No Candidate will be eligible who has not passed the Final Examination of the Incorporated Law Society of the United Kingdom, and each Candidate must have served for five years as articled clerk to a solicitor in actual practice, or for four years if he has proved his title to be admitted after being articled for four years, or for three years if he is a graduate of a University. Each Candidate will be required to produce the certificate of his having passed the Final Examination of the Incorporated Law Society of the United Kingdom, or the certificate of his admission, if he has been admitted, and also a certificate from the solicitors with whom he served his articles, that during his clerkship he was actually employed in Conveyancing and Chancery business.

III. The Examination will be in the following subjects :—

Obligatory Subjects.

1. Handwriting and Orthography.
2. Arithmetic (including Vulgar and Decimal Fractions).
3. English Composition.
4. Law of Real and Personal Property (including Conveyancing).

Optional Subjects.

5. History of England, and of the Constitution.
6. Any two of the following languages: Latin, French, or German.

IV. Application for permission to attend an Examination must be made at such time and in such manner as the Commissioners may appoint.

V. A fee of £2 will be required from every Candidate attending the Examination.

The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in London, under the foregoing Regulations, commencing on the 3rd January, 1893. The number of situations to be filled will be fifteen, if so many candidates shall be found to be duly qualified.

No person will be admitted to Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 21st December, 1892, an application, in the handwriting of the Candidate, on a prescribed form, which may be obtained from the Secretary at once.
