THE Queen has been pleased to give and grant unto Captain John Robert Beech, C.M.G., D.S.O., 20th Hussars, Her Majesty's Royal licence and authority that he may accept and wear the Insignia of the Order of the Osmanieh of the Fourth Class, which His Highness the Khedive of Egypt, authorized by His Imperial Majesty the Sultan, has been pleased to confer upon him in recognition of his services whilst actually and entirely employed beyond Her Majesty's Dominions in the service of the Egyptian Government.

THE Queen has been pleased to grant unto Quintin Dick Hume, of St. James's-square, in the parish of St James, Westminster, in the county of London, Esquire, late a Captain in the Derbyshire Yeomanry Cavalry, and Royal Antrim Rifles, Her Royal licence and authority that he and his issue may, in compliance with a clause contained in the will of his grand-uncle, Quintin Dick, late of Mayfair, in the county of Middlesex, Esquire, deceased, take and henceforth use the surname of Dick only, in lieu of that of Hume, and that he and they may bear the arms of Dick:

And to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms, otherwise to be void and of none effect.

THE Board of Trade have received, through the Secretary of State for the Colonies, a copy of a Telegram, dated 23rd November, 1892, from Her Majesty's Representative at Malta, stating that the quarantine on arrivals from Porto, with clean bills of health, has been abolished, but ten days is imposed from the date of arrival in Malta, if with foul bills of health.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegrams from Her Majesty's Representatives at Constantinople and Bucharest.

Constantinople, November 27, 1892.—“Quarantine on arrivals from Theodosia and from Kertsch with passengers on board maintained at ten days; without passengers on board reduced to five days.”

“Quarantine on arrivals from Sebastopol with passengers on board reduced from ten to five days; without passengers on board to forty-eight hours.”

Bucharest, November 28, 1892.—“Quarantine against arrivals from Marseilles abolished.”
