THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 6th December, 1892, from Her Majesty's Representative at Madrid, enclosing a Royal Order published on the same date, stating that the pratique granted to arrivals from Hamburg is dependent on their having clean bills of health, duly visaed, being in good health on board, and otherwise not contravening quarantine regulations. The Order further declares that the Royal Orders of the 25th and 29th August, referring to the refusal of admission or disinfection of dangerous goods, and the medical inspection of passengers, are annulled, so far as they relate to arrivals from Germany.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 1st December, 1892, from Her Majesty's Representative at Sofia, enclosing the following Quarantine Regulations issued by the Bulgarian Government:—

1. Travellers arriving from Roumania are submitted to a medical observation of twenty-four

hours in the quarantine stations.

2. Travellers arriving from Austria-Hungary and Servia by the Danube or by Tzaribrod are subjected to five days' quarantine.

Note.—The quarantine at Tzaribrod was on the 8th instant, reduced to three days, and on the 10th instant, to twenty-four hours' observation.

3. The baggage of passengers is carefully dis-infected in the disinfecting stove.

- 4. The importation into Bulgaria of preserved articles such as sardines, lobsters, &c., is permitted if the coverings in which they are contained are hermetically sealed, and after they have undergone the established quarantine and been externally disinfected.
- 5. The importation of maccaroni and farinaceous matters is likewise permitted after having undergone the established quarantine. Farinaceous matters contained in quite new sacks are, however, exempted from disinfection.
