## THE PROHIBITION OF MOVEMENT FROM LONDON ORDER OF 1893.

#### By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

### Prohibition of Movement out of County of London and City of London.

1. No cattle, sheep, goats, or swine shall be moved either by land or by water out of the District described in the Schedule to this Order : Provided that nothing in this Order shall be deemed to apply to the movement of animals by railway through the said district from a place outside the said district to another place outside the said district without untrucking within the said district.

#### Offences.

2. If a head of cattle or a sheep or a goat or a pig is moved in contravention of this Order, the owner of the animal, and the person for the time

being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Contagious Diseases (Animals) Act, 1878.

#### Short Title.

3. This Order may be cited as THE PROHIBI-TION OF MOVEMENT FROM LONDON ORDER OF 1893.
