GENERAL ORDER of the Local Government Board: Amending Regulations with respect to Remuneration of Vaccination Officer:—

Kings Norton Union.

To the Guardians of the Poor of the Kings Norton Union, in the counties of Worcester

and Stafford and the county Borough of Birmingham:—

And to all others whom it may concern.

WHEREAS We, the Local Government Board, by a General Order dated the thirty-first day of October, one thousand eight hundred and seventy-four, made rules and regulations relating to the appointment of Vaccination Officers by Guardians of the Poor of certain Unions and Parishes, including the said Kings Norton Union; and by Article 9 of that Order it was provided as follows:—

“The Guardians shall pay to any Vaccination Officer such salary or remuneration, and such only, as the Local Government Board may direct or approve, whether for ordinary duties or for occasional services; and such salary or remuneration may be increased or reduced as that Board may from time to time direct or approve.”

And whereas it is expedient to amend the said Order as hereinafter mentioned, so far as regards the said Kings Norton Union:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order that, with respect to the said Kings Norton Union, the above-cited Article shall be amended by the addition of the following proviso:—

Provided that the Guardians, with the approval of the Local Government Board, may pay to any Vaccination Officer a reasonable compensation on account of extraordinary services, or other unforeseen circumstances connected with his duties or the necessities of the said Union.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Notwithstanding anything contained in the Prohibition of Movement from London Order of 1893 dated the second day of January, one thousand eight hundred and ninety-three, the following animals, namely, twenty-six fat cattle and eleven sheep of the Hampshire breed may on or about this fourth day of January, one thousand eight hundred and ninety-three, be placed on board a vessel belonging to the General Steam Navigation Company at Irongate Wharf or at any other wharf in the county of London or in the city of London for exportation to Ostende.

In witness whereof the Board of Agriculture have hereunto set their Official Seal this fourth day of January, one thousand eight hundred and ninety-three.
