## THE FAIRS ACT, 1871.

## STEBBING FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Herbert H. Asquith, one of Her Majesty's Principal Secretaries of State, hereby notify as follows :—

1. By Memorial, dated the 2nd day of January, 1893, a representation has been duly made to me by the Justices of the Peace acting in and for the Petty Sessional Division of Dunmow, in the county of Essex, that a Fair has been annually held on the 10th and 11th days of July, in a certain public street or highway in the village and parish of Stebbing, within the said Petty Sessional Division of Dunmow, and that it would be for the convenience and advantage of the public that such Fair should be abolished :

2. On the 26th day of February, 1893, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.

Local Government District of Clay Lane.

To the Clay Lane Local Board, being the Sanitary Authority for the Urban Sanitary District of Clay Lane, in the County of Derby ;—

And to all others whom it may concern.

WHEREAS by Section 311 of The Public Health Act, 1875, it is enacted as follows :—

“ Any Local Board constituted either before or after the passing of this Act may, with the sanction of the Local Government Board, change their name. Every such change of name shall be published in such manner as the Local Government Board may direct” ;

And whereas the said Clay Lane Local Board, at a Meeting held, after due notice, on the 19th day of December, 1892, resolved that their name should be altered to the “ Clay Cross Local Board,” and have made application to Us, the Local Government Board, to sanction such change of name :

Now, therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby give Our sanction to the name of the said Local Board being changed to the “ Clay Cross Local Board” :

And We hereby direct that the Clay Cross Local Board shall cause this Order to be published during two successive weeks in some newspaper circulating within their District, within one calendar month from the date hereof.
