(1.) The ten days' quarantine imposed on arrivals from Persia, from Hameguine to Bassorah exclusive, is reduced to five days. The bringing in of dead bodies is, nevertheless, absolutely prohibited. To date from the 24th January

(2.) Arrivals with passengers on board from the Montenegrin coast of the Adriatic are subjected to a strict medical visit only. To date from the 24th January.

(3.) The medical visit imposed on arrivals from London, Liverpool, Glasgow, Grimsby, Shields, and Swansea, and from Egypt, Italy, France, and New York is abolished from the 18th January.

(4.) The twenty-four hours' observation imposed on arrivals from the north of Europe, comprising Belgium, Holland, and Germany, and the five days' quarantine on vessels from the Gulf of Finland, are replaced by a strict medical visit. To date from 24th January.

The following Telegrams have also been received, dated Constantinople, 7th February, 1893 :-

" Quarantine on arrivals at Mustapha Pacha Station reduced to a strict medical visit, with disinfection of clothes and baggage. Detention at station will be not less than twelve hours."

" Quarantine on arrivals from Zibeftche reduced from five days' to twenty-four hours' observation, with disinfection of clothes and baggage."
