School Fees Order Sheets according to the Form prescribed for the School Fees Order Book by the said General Order of the Local Government Board dated the 22nd day of March, 1877, shall be kept for the use of each Rel ef Committee, and, before each meeting of the Committee, the first four columns in a fresh Relief Order Sheet and a fresh School Fees Order Sheet shall be entered up by the Clerk to the Board of Guardians, or, if he cannot do this, by the: Relieving Officer whose District or a part thereof has been assigned to such Committee, and the remaining columns in each sheet shall be filled up at the Meeting with the particulars of the decisions or directions of the Committee, by one of the Meinbers of the Committee or by the Clerk, and the sheet shall then be signed by the presiding Chairman of the Committee.

: ARTICLE IX .- The Relief Order Sheets and the School Fees Order Sheets, so scon as they have been filled up and signed as required by Article VIII, shall be handed to the Clerk to the Board of Guardians or transmitted to him in closed envelopes by the presiding Chairman of each Committee, and the Clerk shall lay the sheets before the Board of Guardians at their next ordinary meeting, and shall thereupon enter on the Minutes of the Board of Guardians a record of the fact of such sheets having been so laid before them.

ARTICLE X .- The said Relief Order Sheets and School Fees Order Sheets shall remain in the custody of the Clerk to the Board of Guardians, and shall be bound up into Books at the end of each balf-year or year, as the Guardians may direct.
