(a.) The names of the owners, lessees, occupiers of the lands described in the said Provisional Award, so far as they can be ascertained;

(b.) The apportioned amounts in capital sums and by way of annual charge which in the opinion of the Council ought to be charged upon such

lands respectively;

It further provides that the amount to be proposed in the Provisional Award as the capital sum to be charged on any lands shall be one-half of the amount which in the opinion of the Council will be the enhanced value or benefit derived or to be derived by the said lands from the improvements, and the amount to be proposed in the Provisional Award as the annual charge upon the lands charged shall be an annual sum equal to three per centum per annum on the amount of the capital charge in respect of the same lands.

· The clause also contains various provisions as to the method in which objections may be made to the Award; for referring the award to an Arbitrator to be appointed by the Local Government Board, who shall have power to deal with all objections to the Award, and to amend the resolution of the Council and the Award.

Other parts of the same clause contain provisions as to the recovery of the amount to be charged, which may be registered as a land charge under "The Lands Charges Registration and

Searches Act, 1888."
