THE Queen has been pleased to grant unto John Compton Hanford-Flood, of Woollas Hall, in the parish of Eckington, in the county of Worcester, formerly of Farmley, in the county of Kilkenny, Esquire, Lieutenant-Colonel in Her Majesty's 19th Regiment of Hussars, Her Royal licence and authority that he and his issue may, in compliance with a clause contained in a certain Indenture of Settlement, take and henceforth use the surname of Hanford only in lieu of those of Hanford-Flood, and that he and they may bear the arms of Hanford only; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect.

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
