STEBBING FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices acting in and for the Petty Sessional Division of Dunmow, in the county of Essex, that a Fair has been annually held in a certain public street or highway in the village and parish of Stebbing, within the said Petty Sessional Division of Dunmow, on the 10th and 11th days of July, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas Mr. S. D. Chopping, as lord or owner of the said Fair and the tolls thereof, has consented, in writing, that the said Fair should be abolished:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held in a certain public street or highway in the village and parish of Stebbing, within the Petty Sessional Division of Dunmow, on the 10th and 11th days of July, shall be abolished as from the date of this Order.

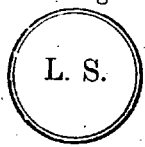

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Order described in the Schedule to this Order is hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Order hereby revoked, or affect any licence or authority granted, or any right, title, obligation, or liability accrued thereunder before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Order hereby revoked before the commencement of this Order.

2. This Order shall commence and take effect from and immediately after the fifteenth day of March, one thousand eight hundred and ninety-three.
