United Kingdom as you may deem it expedient so to inspect, for the more effectual carrying out

of the purpose aforesaid.

And We do further by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof and of every matter and thing thereiu contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matter herein submitted for your consideration.

Given at Our Court at Saint James's, the twenty-seventh day of March, one thousand eight hundred and ninety-three, in the fifty-sixth year of Our Reign.
