## By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Glasgow as a foreign animals wharf :

All that space in the Port of Glasgow being part of the lands of Shieldhall belonging to the Trustees of the Clyde Navigation situate on the south bank of the river Clyde, bounded by a line commencing at a point on the coping of the river wall on the south bank of the river Clyde distant forty feet or thereabouts westward from the boundary between the said lands of Shieldhall and Linthouse Shipbuilding-yard ; thence passing in a westerly direction along the coping of the river wall for a distance of fifty-four feet three inches or thereabouts; thence northward along the coping of a dolphin or jetty for a distance of twelve feet ten inches or thereabouts; thence westward along the said coping for a distance of eight feet six inches or thereabouts ; thence southward along the said coping for a distance of twelve feet ten inches or thereabouts; thence westward along the coping of the river wall for a distance of eighty-seven feet six inches or thereabouts; thence northward along the coping of a jetty for a distance of twenty-five feet nine inches or thereabouts; thence westward along the said coping for a distance of fourteen feet or thereabouts; thence southward along the said coping for a distance of twenty-five feet nine inches or '
