THE Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz. :—

SPECIAL REGULATIONS (supplementary to the General Regulations issued 8th April, 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the situation of Assistant in the Nautical Almanac Office of the Admiralty.

N.B.—*These Regulations are liable to alteration for future Examinations.*

I. The limits of age for this situation are 18 and 25, and Candidates must be of the prescribed age on the first day of the examination.

II. The Examination will be in the following subjects:—

1. Handwriting and Orthography.
2. Arithmetic (including Vulgar and Decimal Fractions).
3. Algebra (including Quadratic Equations).
4. Logarithmic solution of plane and spherical triangles.
5. Astronomical computations, including the conversion of longitude and latitude into right ascension and declination.
6. French (translation into English).
7. German (translation into English).

The first five subjects are obligatory.

III. A fee of £1 will be required from every Candidate attending the Examination.

IV. Application for permission to attend an Examination must be made at such times and in such manner as the Civil Service Commissioners may appoint.

The Civil Service Commissioners further give notice, that an Open Competitive Examination for the situation of Assistant in the Nautical Almanac Office will be held in London, under the foregoing Regulations, commencing on the 31st May, 1893.

The number of situations to be filled will be the number vacant at the time of the Examination.

No person will be admitted to Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 19th May, an application, in the handwriting of the Candidate, on a prescribed form, which may be obtained from the Secretary at once.

THE Civil Service Commissioners hereby give notice, that an Open Competitive Examination for the situation of Out-Door Officer in the Customs Department will be held in London, Edinburgh, Dublin, Birmingham, Bristol, Hull, Leeds, Liverpool, Newcastle-on-Tyne, Plymouth, Portsmouth, Swansea, Aberdeen, Dundee, Glasgow, Belfast, Cork, Galway, and Limerick, commencing on the 6th June, 1893, under the Regulations dated 31st July, 1891, and published in the London Gazette of the same date. Seventy Candidates will be appointed on the result of this Examination if so many should be found duly qualified.
