THE Queen has been pleased to grant unto Henry Liddell, of Middleton Hall, in the parish of Belford, in the county of Northumberland, Esquire, Her Royal licence and authority that he and his issue may, in compliance with a clause contained in the last will and testament of Thomas Charles Grainger, late of Newcastle-upon-Tyne, Esquire, assume and use the surname

of Grainger in addition to and after that of Liddell, and that he and they may bear the arms of Grainger quarterly with his and their family arms; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 30th May, 1893, from Her Majesty's Representative at Lisbon, stating that Russian ports are suspected of cholera from the 1st May.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Quarantine Notice, issued by the Turkish Board of Health, to the effect that the medical visit imposed on arrivals from Belgium, Holland, the Gulf of Finland, Kurrachee, and the Coast of the Sea of Azov (Taganrog to Yesk), is suppressed from the 25th May.

A Telegram has also been received from Her Majesty's Representative at Constantinople, stating that the Sanitary Inspector at Bagdad reports outbreak of cholera at some stations on the River Tigris and at Bassorah. Traffic between Bassorah and Bagdad by river boats is interrupted.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following copy of a Telegram from Her Majesty's Representative at Madrid, viz.:—"Departures from Marseilles after 21st May, and arriving on or after 1st June, declared foul. Ports within 165 kilometres of Marseilles likewise foul."
