*S. W. Spit Buoy Altered in Position.*

THE Trinity House, London, has given notice, dated 23rd May, 1893, that in consequence of the extension of Welsh Hook, South-West Spit Buoy has been moved about two cables W.N.W. from its previous position, and now lies in 23 feet at low water spring tides, with English and Welsh Grounds Light-vessel bearing S.  $\frac{1}{2}$  E., distant  $1\frac{1}{10}$  miles, and East Cardiff Buoy W. by N.  $\frac{1}{4}$  N., Nly.
