Information has been received from the Deputy Queen's Harbour Master at Sheerness, dated 31st May, 1893, that a new beacon has been erected on Grain Island, to serve as a leading mark for the entrance channel of the River Medway. This new beacon appears, when viewed from the sea, like an Obelisk, and is coloured red and white in horizontal stripes. From it the Outer Black Beacon bears S. 89° E., distant $7\frac{1}{2}$ cables, and beacon on Cockle Shell Hard S. 17° E. This beacon kept in line with the south extreme of the Martello Tower N. 89° W. leads in the deepest water over the bar of the River Medway.

INFORMATION has been received that, towards the end of the year 1893, it is intended to exhibit a light from a lighthouse, now in course of construction, and situated about 100 yards southward of the north extreme of Psathura (Psathoura) Island, Skopelo Group:-Psathura Island Light will be a fixed white

light, visible in all directions, except where obscured by Pelago, Iura, and Piperi Islands. It will be elevated 130 feet above the sea, and should be seen in clear weather from a distance of about 17 miles.

The illuminating apparatus will be dioptric, of the second order.

The lighthouse will be a cylindrical stone tower rising from the centre of the keeper's dwelling, and 84 feet in height.


