the centre of Union-street to Broad-street, thence in a north-easterly direction to and along the centre of Broad-street to a point opposite to the centre of Back Petteril-street South, thence in a south-easterly direction to and along the centre of Back Petteril-street South, to the centre of an ancient lane known as Halfey's Lonning, thence in an easterly direction along the centre of the said Lonning to the centre of Botcherby Old-road, thence in a north-easterly and northerly direction along the centre of Botcherby Old-road to the centre of Warwick-road, thence in an easterly direction along the centre of Warwick-road to the boundary of the city at Botcherby Bridge over the River Petteril, thence in a southerly direction along the said boundary to Harraby Bridge, thence in a southerly and westerly direction along the said boundary of the city to Currock-road, thence to and along the centre of Currock-road in a northerly direction to Crown-street, thence in a north-easterly direction to and along the centre of Crown-street to the point of commencement aforesaid.

" And I do hereby determine that Ward No. 2 otherwise Caldewgate Ward shall comprise so much of the area of the city of Carlisle as is contained within a line commencing from the said point in the centre of Botchergate opposite to the centre of Crown-street, thence in a southerly direction along the western boundary of Ward No. 1 to the boundary of the city, thence in a westerly direction along the said boundary to Dalston-road, thence in a northerly direction to and along the centre of Dalston-road to a point opposite the centre of Nelson-street, thence in an easterly direction to and along the centre of Nelson-street to a point opposite to the centre of Blencowe-street, thence in a northerly direction to and along the centre of Blencowe-street to Lorne-crescent, thence in a northerly direction to and along the centre of Lorne-crescent to Charlotte-street, thence to and along the centre of Charlotte-street in an easterly direction to Victoria-viaduct, thence in a north-easterly direction to and along the centre of Victoria-viaduct to a point above the centre of Borough-street, thence by a vertical line to the centre of Borough-street thence in an easterly direction along the centre of Borough-street to Court-square Brow, thence to and along the centre of Court-square Brow to the centre of Court-square thence in a north-easterly direction to a point in English-street opposite to the centre of Botchergate, thence in a south-easterly direction to and along the centre of Botchergate to the point of commencement aforesaid.

And I do hereby determine that Ward No. 3 otherwise Saint Cuthbert's Ward shall comprise so much of the area of the city of Carlisle as is contained within a line commencing from the Market Cross, thence in an easterly direction by a direct line to a point opposite to the centre of New Grapes-lane, thence in an easterly direction to and along the centre of New Grapes-lane to Lowther-street, thence to and along the centre of Lowther-street in a southerly direction to the Crescent, thence in a southerly direction to and along the centre of the Crescent to the boundary of Ward No. 2, thence in a westerly and southerly direction along the boundary of Ward No. 2 to the boundary of the city, thence in a north-westerly direction along the boundary of the city to Wigton-road, thence in a north-easterly direction to and along the centre of Wigton-road to Church-street, thence in a north-easterly direction to and along the centre of Church-street to Bridgestreet, thence in a north-easterly direction to and

along the centre of Bridge-street to Caldew Bridge. thence in an easterly direction to and along the centre of Caldew Bridge and Irish Gate to the point of intersection of Annetwell-street, Abbey street, and West Walls, thence in a south-easterly direction to and along the centre of West Walls to a point opposite the centre of an ancient way leading to the Western Gate of the Cathedral Close, thence in a north-easterly direction to to and along the centre of the said ancient way to Paternoster-row thence in a north-easterly direction along the centre of Paternoster-row to the centre of Castle-street thence in a south-casterly direction along the centre of Castle-street to the Green Market thence to and along the centre of the Green Market to the Market-place and thence by a straight line to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 4 otherwise Saint Mary's Ward shall comprise so much of the area of the city of Carlisle as is contained within a line commencing from the Market Cross aforesaid thence in a westerly and south-westerly direction along the boundary of Ward No. 3 to the boundary of the city thence in a north-westerly and northerly direction along the said boundary to the centre of the River Eden thence in an easterly direction along the boundary of the city to a point beneath the centre of Eden Bridge thence by a vertical line to the centre of the said bridge thence in a southerly direction along the centre of Eden Bridges to Rickergate thence to and along the centre of Rickergate to Scotchstreet thence to and along the centre of Scotch-street to the boundary of Ward No. 3 thence along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 5 otherwise Rickergate Word shall comprise so much of the area of the city of Carlisle as is contained within a line commencing from the Market Cross aforesaid thence in a northerly direction along the eastern boundary of Ward No. 4 to the boundary of the city thence in an easterly direction along the said boundary to the north-eastern extremity of the city thence in a southerly direction along the boundary of the city to Botcherby Bridge, thence in a westerly, southwesterly and north-westerly direction to the boundary of Ward No. 2 thence along the northeastern boundary of Ward No. 2 to the boundary of Ward No. 3 thence along the eastern boundary of Ward No. 3 in a northerly and westerly direction to the point of commencement aforesaid.

"And I the said Charles Neve Cresswell by virtue of the power vested in me by the said Warrant of Appointment do hereby assign and apportion six Councillors to each Ward as follows, that is to say :-
