

the centre of Newport-road, thence in a south-westerly direction along the centre of Newport-road to a point opposite to the centre of Hartington-road, thence in a south-easterly direction to and along the centre of Hartington-road to the centre of Borough-road West, thence in an easterly direction to and along the centre of Borough-road West to the centre of Linthorpe-road, thence in a northerly direction along the centre of Linthorpe-road to the boundary of Ward No. 3, thence in a northerly direction along the said boundary to the boundary of Ward No. 2, and thence along the boundary of Ward No. 2 in a northerly direction to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 5 otherwise 'Cannon' Ward shall comprise so much of the area of the borough of Middlesbrough as is contained within a line commencing from the point in the centre of West Bridge aforesaid thence in a westerly direction along the boundary of Ward No. 1 to a point opposite to the centre of Britannia-street, thence in a south-easterly direction to and along the centre of Britannia-street to Marsh-road, thence by an oblique line to a point opposite to the centre of Calthorpe-street, thence in a south-easterly direction to and along the centre of Calthorpe-street to the centre of Newport-road, thence in a north-easterly direction along the centre of Newport-road to the boundary of Ward No. 4, thence in a north-easterly and northerly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 6 otherwise 'Newport Ward' shall comprise so much of the area of the borough of Middlesbrough as is contained within a line commencing from the point in the centre of Newport-road, opposite to the centre of Calthorpe-street thence in a south-westerly direction along the centre of Newport-road to a point opposite to the centre of Laws-street, thence in a north-westerly direction to and along the centre of Laws-street to the centre of Higher Cannon-street, thence in a north-westerly direction by a straight line to the boundary of Ward No. 1, thence in a north-easterly direction along the said boundary to the boundary of Ward No. 5, thence in a south-easterly direction along the boundary of Ward No. 5 to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 7 otherwise 'Acklam' Ward shall comprise so much of the area of the borough of Middlesbrough as is contained within a line commencing from a point in the centre of Newport-road opposite to the centre of Hartington-road, thence in a south-easterly direction along the boundary of Ward No. 4 to the centre of Linthorpe-road, thence in a southerly direction along the centre of Linthorpe-road, to a point opposite to the centre of Princes-road thence in a westerly direction to and along the centre of Princes-road to a point opposite to the centre of Walpole-street, thence in a north-westerly direction to and along the centre of Walpole-street to the centre of Union-street, thence in a south-westerly direction to and along the centre of Union-street to a point opposite to the centre of Glebe-road, thence in a north-westerly direction to and along the centre of Glebe-road to the boundary of Ward No. 6 thence in a north-easterly direction along the said boundary to the boundary of Ward No. 5 thence in a north-easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 8 otherwise 'Ayresome' Ward shall comprise so

much of the area of the borough of Middlesbrough as is contained within a line commencing from the point in the centre of the Linthorpe-road opposite to the centre of Princes-road, thence in a southerly direction along the centre of Linthorpe-road to a point opposite to the centre of New Cemetery-road, thence in a westerly direction to and along the centre of the New Cemetery-road to the centre of Ayresome Green-lane, thence in a southerly direction along the centre of Ayresome Green-lane to a point opposite to the centre of an old highway leading to Acklam, thence in a westerly direction to and along the centre of the said old highway to the boundary of the borough, thence in a northerly direction along the said boundary to the boundary of Ward No. 1, thence in a north-easterly direction along the boundary of Ward No. 1 to the boundary of Ward No. 6, thence in a south-easterly and north-easterly direction along the boundary of Ward No. 6 to the boundary of Ward No. 7, thence in a south-easterly, north-easterly and easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 9 otherwise 'Linthorpe Ward' shall comprise so much of the area of the borough of Middlesbrough as is contained within a line commencing from the point aforesaid in the centre of Linthorpe-road opposite to the centre of Princes-road, thence in a southerly-westerly, south-easterly and westerly direction along the boundary of Ward No. 8 to the boundary of the borough, near the western boundary of the new cemetery, thence in a westerly-southerly and easterly direction along the said boundary to a point in the centre of Marton West Beck, thence in a northerly direction along the centre of Marton West Beck to a point opposite to the centre of Park-road South, thence by a straight line to a point opposite to the centre of Park Vale-road, thence in a northerly direction to and along the centre of Park Vale-road to a point opposite to the centre of Park-road North, thence in a westerly direction to and along the centre of Park-road North to a point opposite to the centre of Park-lane thence to and along the centre of Park-lane, in a northerly and westerly direction to a point opposite to the centre of Palmerston-terrace, thence in a northerly direction to and along the centre of Palmerston-terrace to the centre of Southfield-road, thence in a westerly direction along the centre of Southfield-road to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 10 otherwise 'Grove Hill' Ward shall comprise so much of the area of the borough of Middlesbrough as is contained within a line commencing from a point in the centre of Linthorpe-road opposite to the centre of Grange-road East, thence in an easterly direction along the boundary of Ward No. 3, to the boundary of Ward No. 2, thence in an easterly direction along the boundary of Ward No. 2 to the boundary of the borough, thence in a southerly and south-westerly direction along the said boundary of Ward No. 9 thence in a northerly, westerly-northerly, and westerly direction along the boundary of Ward No. 9 to the boundary of Ward No. 7 thence in a northerly direction along the boundary of Ward No. 7 to the boundary of Ward No. 4, thence in a northerly direction along the boundary of Ward No. 4 to the point of commencement aforesaid.
