THE following Statutes made by the Governing Body of Trinity College, Oxford, on the nineteenth day of June, one thousand eight hundred and ninety-three, have been submitted for the approval of Her Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions contained in the Universities of Oxford and Cambridge Act, 1877 :----

Trinity College, Oxford AT a General Meeting of the Governing Body of Trinity College, Oxford, specially summoned for the purpose with notice of the business to be transacted thereat, held on Monday June nineteen one thousand eight hundred and ninety-three it was resolved by a majority of not less than two-thirds of those present and voting, in accord-ance with the provisions of Stat. XIII to alter the College Statutes in the following particulars, and the said Statutes as altered were ordered to be sealed.

1. As to number of Official Fellows:

**B** 2

In Statute II clause 2 to substitute "eight" for "seven."

In Statute II clause 6 (c) to substitute "nine" for "eight."

In Statute II clause 8 to substitute "eight" for "seven."

2. As to Honorary Scholarships :-

After Statute III clause 7 to add the following new clauses :

"Any Candidate for a Scholarship shall be allowed when he enters his name for the examination to inform the President that he desires only the rights and privileges of a scholar without the emoluments, and any such Candidate if he is successful in the competition shall enjoy those rights and privileges only, without emoluments, and shall be regarded as an Honorary Scholar, the whole number of vacancies advertised being filled up if suitable Candidates present themselves, as if no such Honorary Scholar had been elected.

"Any Scholar may at any time during the tenure of his Scholarship, if he think fit relinquish the whole or any part of the emoluments thereof for the benefit of the Exhibition Fund hereinafter mentioned without losing any other of the rights or privileges of a Scholar. Any emoluments so relinquished shall be paid into the Exhibition Fund in addition to the other income appropriated thereto.

" The President and Fellows may from time to time elect to an Honorary Scholarship any member of the College who has not exceeded his ninth term from Matriculation, and has either obtained a first class in a Public Examination in the University or a University Scholarship or a Prize open without restriction to all members of the University and whom they shall judge of sufficient merit for election; and any such Honorary Scholar shall enjoy the rights and privileges only of a Scholar without emolument and any such Honorary Scholarship shall be tenable for such a term as the President and Fellows shall determine, provided always that no such Honorary Scholarship shall be tenable by anyone after the expiration of the twentieth term from his Matriculation."

3. As to Pension Fund:

For Statute VI clause 2 to substitute the following clause.

" The income of the Fund (including the sums paid to it yearly from Corporate Revenue and from the Tuition Fund) shall be applicable to the payment of pensions, subject to such regulations and conditions as the College may determine by Bye-laws to be made from time to time. Provided that if any official Fellow, having served the College as Tutor, Bursar, or Lecturer thirty years, shall (without default or misconduct on his part) not be rc-elected a Fellow, or voluntarily retire from his Fellowship, he shall be entitled as of right to a pension of £2:0 per annum for life subject only to the provisions hereinafter contained : and if any Official Fellow having served the College as Tutor or Lecturer twenty-five years shall (without default or misconduct on his part) not be re-elected a Fellow, he shall be entitled as of right to a pension of £200 per annum for life, subject only to the provisions hereinafter con-tained. Provided that no pension shall be granted which the said Fund shall not in the judgment of the President and Fellows be sufficient to satisfy ; and that the President and Fellows may grant such pension as they think fit to any person who has served the College as Tutor or Lecturer less than twenty-five years, should ill-health or other exceptional circumstances render such grant in their opinion necessary ; and that no person hold-
