(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—the cow-sheds and farmyards on the Model Farm, and on Church End Farm, Hendon, in the county of Middlesex, in the occupation of Mr. Frederick Hinge,—which was declared by Order of the Board dated the twenty-sixth day of May, one thousand eight hundred and ninety-three, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the thirtieth day of June, one thousand eight hundred and ninety-three.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1892, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The sale or exposure for sale of any cattle sheep or swine in or at either of the sale-yards named in the Schedule to this Order is hereby prohibited.

2. If a head of cattle or a sheep or a pig is sold or exposed for sale in or at either of the sale-

yards named in the Schedule to this Order in contravention of this Order, the owner and the lessee and the occupier of the sale-yard, and the owner or consignee of each head of cattle and of each sheep or pig so sold or exposed, and the person so selling or exposing the same, and the auctioneer, if any, or other person conducting a sale of cattle sheep or swine at such sale-yard, and the purchaser thereof of any cattle sheep or swine so sold or exposed in contravention of this Order, such purchaser knowing the animal to be sold or exposed for sale in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Contagious Diseases (Animals) Act, 1878.

3. This Order shall take effect from and immediately after the thirtieth day of September, one thousand eight hundred and ninety-three.
