where the last-mentioned boundary meets the boundary which divides the said township of Offerton from the township of Stockport and extending thence southward along the said township boundary for a distance of thirteen chains or thereabouts to a point at the junction of Offertonlane with Hempshaw-lane aforesaid and extending thence generally westward along the middle of the last-named lane for a distance of fifty chains or thereabouts (thereby following from Four-lane ends the said boundary which divides the said parish of Saint Mary Stockport from the parish of Saint Thomas Stockport aforesaid) to the firstly above-mentioned point at the junction of the said Hempshaw-lane with Webb-lane aforesaid at which point the said imaginary line commenced.

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore-mentioned Act, been transmitted to the patrons and to the incumbents of the two cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patrons and incumbents have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chester.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-ninth day of June, in the year one thousand eight hundred and ninety-three, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen and of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven have prepared and now humbly lay before Your Majesty in Council the following Scheme for constituting a separate district for spiritual purposes to be taken out of the district chapelry of All Saints Falsgrave in the county of York and in the diocese of York.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said district chapelry of All Saints Falsgrave which is hereinafter mentioned and described should be constituted a separate district in manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship.

And whereas the Reverend Frederick Harton Holt of Saint James's Lodge Scarborough in the said county of York Clerk in Holy Orders has contributed and paid to the credit of our account at the Bank of England a sum of four thousand and three hundred pounds sterling in aid of the endowment of the district hereinafter recommended to be constituted and so soon as the said district shall have become a new parish under the provisions of the secondly hereinbefore mentioned Act then of the said new parish and of the maintenance of the minister or incumbent thereof for the time being and we have in respect of such sum agreed and have undertaken to provide and pay by equal half-yearly payments on the first day of May and the first day of November in each and every year to such minister or incumbent as aforesaid when duly licensed in accordance with the provisions of the lastly-mentioned Act the sum of one hundred and twenty-nine pounds per annum so long as the said capital sum shall remain in our hands.

"And whereas the said capital sum of four thousand and three hundred pounds sterling has been so contributed and paid as aforesaid upon the understanding and condition that we should also grant out of the common fund created by the firstly herein-named Act to the said proposed district or new parish a capital sum of seven hundred pounds in respect of which there shall be paid by us to the minister or incumbent of the said proposed district or new parish when duly licensed as aforesaid a yearly sum of twenty-one pounds and upon the further understanding and condition that (such arrangement appearing to us to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of patronage of the said district or new parish and of the nomination of the minister or incumbent thereof should be assigned in the manner hereinafter set forth.

"And whereas the said Frederick Hartop Holt has nominated to us the said Ecclesiastical Commissioners for England, as the person and as the corporation sole in whom he desires that the whole right of patronage of the said proposed district or new parish and of the nomination of the minister or incumbent thereof should be vested, himself, the said Frederick Hartop Holt for his life, and subsequently the Archbishop of York and his successors for ever.

"And whereas the said grant of twenty-one pounds will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme, be made and secured by an instrument to be executed by us the said Commissioners under our common seal in accordance, with the provisions of the Act of the twenty-ninth and thirtieth years of Your Majesty chapter one hundred and eleven.

" Now therefore with the consent of the Right Honourable and Most Reverend William Dalrymple Archbishop of York (in testimony whereof he the said archbishop has signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all that part of the said district chapelry of All Saints Falsgrave which is described in the schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint James Scarborough.'
