ARTICLE III.—The District in which the said Sidney Dominic Jerrold shall act as Auditor, and which We hereby assign to him for the performance. of the duties assigned to him by this Order, shall be termed "The North Yorkshire Audit District," and shall, until We otherwise prescribe, comprise the area for the time being included in the several Unions and Highway Districts named in the Schedules to this Order, the District of the Port Sanitary Atthority named in paragraph (5) of Article I of this Order, and the Districts or areas subject to the jurisdiction of any such Authority as is mentioned in paragraph (6) of the said Article I.
