port where there is a health office of any class, and a doctor, and it shall be performed under exactly the same conditions as the quarantine of observation.

If the voyage lasted more than twenty-five days, ships proceeding from cholera-infected districts will be given free pratique after examination of the crew and a severe medical inspection.
