COUNTY OF THE CITY OF GLASGOW ACT, 1893.

ORDER prescribing the day on which "The County of the City of Glasgow Act, 1893," shall come into operation.

Whereas by "The County of the City of Glasgow Act, 1893," it is amongst other things enacted that from and after the day prescribed by the Secretary for Scotland the City and Royal Burgh of Glasgow, as its boundaries are defined by "The City of Glasgow Act, 1891," shall be a County of a City by the name of the County of the City of Glasgow, and that for the purposes of the said Act the area of the said City and Royal Burgh shall be severed from the County of Lanark, within which it was situated on the prescribed day.

Now therefore, I, the Right Honourable Sir George Otto Trevelyan, Bart., Her Majesty's Secretary for Scotland, do hereby appoint Thursday, the 30th day of November, 1893, as the prescribed day for the purposes of the said Act.
