

- (i) Lands and houses wholly in the parish of St. Martin-in-the-Fields, in the county of London, being Nos. 32, 33, 34, 35, 36, and 37, Strand, Nos. 34 and 35, Villiers-street, and No. 2, Buckingham-street.
- (ii) Lands wholly in the said parish of St. Martin-in-the-Fields, in the said county of London aforesaid, containing 1 perch, or thereabouts; being portion of the disused burial ground (now used as a public recreation ground) attached to or adjoining the parish church of the parish of St. Martin-in-the-Fields aforesaid, and situate at the corner of Adelaide-street and Duncannon-street.

To appropriate and use the subsoil under any street or road shown upon the plans to be deposited as hereinafter mentioned, and included within the limits of deviation shown upon those plans, or in connection with the lands shown upon and included within the said limits.

To alter, widen, and enlarge from time to time the Company's authorised works as and when the same may become necessary for the purpose of constructing upon the lands to be acquired as aforesaid any new or altered station, subways for foot passengers, or other works in connection with or necessary or incidental to the Company's undertaking.

To authorise the Company to sell, convey, demise, and lease, or otherwise dispose of, lands, tenements, and hereditaments purchased or acquired under the powers of the Bill, and, so far as may be necessary or expedient, to exempt the Company from the operation of the Lands Clauses Consolidation Act, 1845, with respect to the sale of superfluous lands.

To vary and extinguish all rights and privileges which would or might interfere with the objects of the Bill, and to confer other rights and privileges.

To incorporate with and extend and make applicable with or without modification or alteration to the intended additional lands, all or some of the provisions of the Charing Cross, Euston, and Hampstead Railway Act, 1893, with reference, *inter alia*, to the following matters (that is to say):—The retention and sale of lands, the power to underpin, the temporary occupation and interference with streets during the construction of the Company's authorised works, and the exemption of the Company from the

operation of the 92nd Section of the Lands Clauses Consolidation Act, 1845.

To authorise the Company to apply the capital authorised by the Act of 1893 for all or any of the purposes aforesaid, or of the intended Act.

To alter, amend, extend, and, if need be, repeal the provisions, or some of the provisions, of the several Acts of Parliament following (that is to say): the Local Government Act, 1888, and any other Act or Acts relating to the London County Council and the Charing Cross, Euston, and Hampstead Railway Act, and any other Act or Acts relating to the Company.
