Additional Waterworks; Abstraction of Water from Stream called "Stoupdale Beck"; Compulsory Purchase or Acquisition of Land and Easements; Commonable Lands; Extension of Limits of Supply of Water and Gas; Additional Gas Works and Lands; Manufacture, Storage, and Supply of Gas and Residuals on any lands acquired by the Local Board; Supply of Gas Meters and Fittings; Amendment of Millom Gas and Water Act, 1875, with respect to Sinking Fund, Borrowing Powers, and other matters; Extension of period for repayment of existing Loans; Exoneration of Local Board and its Officers from the provisions of that Act in regard thereto; Further provision as to Sinking Funds; Incorporation, Repeal, Amendment, and Alteration of Acts.

OTICE is hereby given that application is intended to be made to Parliament in the ensuing session by the Local Board for the district of Millom, in the county of Cumberland (hereinafter referred to as "the Local Board") for leave to bring in a Bill for an Act (hereinafter ealled "the intended Act"), to effect the purposes and to confer the powers and privileges following, or some of them, that is to say:—

1. To authorise the Local Board to make and maintain the works hereinafter described, or some

of them (that is to say):-

A dam or weir with sluice inlet from or connected with the stream known as Stoupdale Beck; situate wholly in the parish of No. 26461.

Whicham, in the county of Cumberland, to be formed on the east side of and across the said stream, at a point thereon 300 yards or thereabouts, measured in a northerly direction from the "Sheepfold," situate in the north-west corner of the Enclosure No. 16 on the Ordnance Map of the said parish of Whicham $(\frac{1}{2500}$ th scale.)

An aqueduct, conduit, or line of pipes, situate wholly in the said parish of Whicham, commencing at the south end of the proposed dam or weir hereinbefore mentioned, and terminating at the south-western corner of the existing storage reservoir of the Local Board known as Baystone Bank Reservoir.

The construction and maintenance of additional works in connection with the Local Board's said reservoir, for the purpose of enlarging the area and capacity of such reservoir, and affording means of increasing the storage for water therein, such works to consist of the raising along its entire length of the embankment or retaining wall on the south side of the said reservoir, and the waste weir thereof, to an extent not exceeding 3 feet in height, and the making and maintaining of all other necessary works for effecting such enlargement, and providing for the increased storage capacity of such reservoir, which said work is situate in the parish of Whicham and also in the township of Thwaites, in the parish of Millom, in the county of Cumberland.

compulsion or agreement, and to intercept, abstract, collect, divert, impound, appropriate, and use for the purposes of their water undertaking, authorised by the Millom Gas and Water Act, 1875 (hereinafter called "the Act of 1875"), and for the purposes of the intended Act, the waters of the said stream known as Stoupdale Beck, and all tributaries, brooks, rivulets, water courses and springs which flow into the said stream above the proposed point of abstraction, and all springs, streams, and waters. which can or may be intercepted or taken by the intended works, or which may be found in, upon, or under any lands to be acquired by the Local Board under the powers of the intended Act. The waters so to be abstracted either directly or indirectly flow into the streams or rivers known as Stoupdale Beck, Whicham Beck Kirksanton Beck, and Haverigg Pool, and thence into the estuary of the river Duddon.

3. To empower the Local Board to purchase and take by compulsion or agreement lands, houses, and other property and easements, and other rights in and over lands, houses, streams, springs, waters, mines, and other property required for all or any of the purposes of the intended Act, and for the purposes of the water and gas undertakings of the Local Board, and for the protection of their water works and gas-works against nuisances, encroachments, or injury.
