THE ENGLAND AND WALES MARKETS AND FAIRS (SWINE-FEVER) ORDER OF 1894.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1893, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Extent.

1. This Order shall (except as otherwise expressed) extend and apply to the Districts of all Local Authorities in England and Wales except those Districts and parts of Districts named in the Schedule to this Order, and except any part of any District which may for the time being be included within a Swine-Fever Infected Area declared by the Board for the purposes of the Swine-Fever (Infected Areas) Order of 1894.

Public and Private Sales and Exhibitions of Swine.

2. Notwithstanding any Regulation made by a Local Authority under Article 11 (*Regulations of Local Authority as to Markets, Sales &c.*) of the Swine-Fever Order of 1893, no public or private sale of swine, fat or store, and no exhibition of swine, fat or store, shall be held otherwise than in accordance with the provisions of this Order.

Public Sale of Fat Swine by Licence of Local Authority.

3.—(1.) A public sale of fat swine may be held with a Licence of the Local Authority on the following conditions (namely):

(i.) All swine exposed at the public sale so
