No. 60.—EAST INDIES, CHINA, AUSTRALIA, AND PACIFIC STATIONS.

AUSTRALIA.—BASS STRAIT—BANKS STRAIT.

Swan Island—Exhibition and Alteration of Permanent Light.

THE Government of Tasmania has given notice that, on 1st January, 1894, the permanent light (altered as given below) would be exhibited from the lighthouse on the north-east point of Swan Island, and the temporary light (revolving white) would be discontinued:—

Swan Island permanent light is a white light, fixed, and flashing every minute, elevated 100 feet above the sea, and visible in clear weather from a distance of 15 miles.

The lighthouse is a white tower.

Approximate position, lat. 40° 43' 40" S., long. 148° 7' 50" E.

NORTH SEA.

Sunken Wreck West-North-West of Terschelling Light-vessel.

THE German Government has given notice, that the Master of the Bremen steamer "August" reports having passed, on 16th January, 1894, in lat. 53° 32' N., long. 4° 12' E., or about N.W. by W. $\frac{1}{2}$ W. (N. 63° W.), 24 miles from Terschelling Bank Light-vessel, a broken spar, showing about 6 feet above water, and apparently attached to a sunken wreck lying in a depth of about 16 fathoms.

MEDITERRANEAN.—SICILY—EAST COAST.

Cape Murro di Porco—Temporary Alteration in Character of Light.

THE Italian Government has given notice, dated 26th January, 1894, that in consequence of damage to the light apparatus of Cape Murro di Porco Lighthouse, that light has been temporarily altered from a flashing to a fixed white light.
