BALTIC-RUSSIAN SHORE. Libau—Alteration in Light-vessel and Establish-ment of Fog Signal.

THE Ru sian Government has .given notice, dated 29th December, 1893, that the old lightvessel westward of Libau has been replaced by a new iron steam light-vessel :-

Libau Light-vessel Light is a fixed white electric light, elevated 50 feet above the sea, visible from a distance of 12 miles in clear weather, and shown from the foremast of the light-vessel.

In the event of damage to the electric light apparatus, a light of much decreased power will be exhibited.

The light-vessel, with two masts and a bowspit, is painted red, with the word Либавскій (Libau) in white letters on each side. By day, a red ball, over a yellow flag with a blue cross, is carried on the after mast; and the Russian Imperial ensign is hoisted at the stern.

The light-vessel is moored with Libau Principal Lighthouse bearing E. by S. § S. (S. 72° E.), distant six miles; and remains at her station throughout the year, unless temporarily withdrawn owing to ice.

Approximate position, lat. 56° 32' 15' N., long. 20° 49' E.

Also, that during thick or foggy weather, a steam siren on board this light-vessel will give blasts of ten seconds duration, separated by silent intervals of forty-five seconds. [Variation 6° Westerly in 1894.]

NORTH ATLANTIC OCEAN. Icebergs South-eastward of Newfoundland.

INFORMATION has been published in the Shipping Gazette that several vessels have recently reported icebergs in the North Atlantic, in the area comprised between the parallels of 44° N. and 50° N., and between the meridians of 45° W. and 55° W.

Ice, at this season of the year, being very unusual in this locality, Mariners are warned of its existence and probable extension.


