

formed by him for the University and for the House respectively, the manner in which and the authority by which the performance of these duties may be enforced and provision made for his absence or incapacity, shall be regulated by a Statute or Statutes to be made by the University of Oxford Commissioners for the University, and for the House respectively, or in part for the University, and in part for the House, or under powers to be created by such Statute or Statutes. Provided that the election or appointment to each Readership shall be made by a Board of five persons, one of whom shall be the Dean, and two others shall be nominated on each occasion by the *Governing Body*.

## STATUTE XX.

*Lecturers other than Official Students.*

If it be desirable to appoint Lecturers other than Official Students, such appointment shall rest with the *Governing Body*, who shall have power to terminate such *Lectureships* when they think fit.

## STATUTE XXXIV.

5. Senior Students, who being at present Tutors or Lecturers of the House, shall not be transferred to Official Studentships, shall, for the purpose of holding any College Office, of serving on the *Salaries* Board, of the provisions respecting the number of Official Studentships, and of the residence of four unmarried Students in College, and in applying the provisions of Statute XVI, 12, be reckoned as Official Students so long as they retain their position as Tutors or Lecturers.

A STATUTE in part for the University and in part for the Cathedral or House of Christ Church, concerning Dr. Lee's Readers.

2. The appointment to each Readership shall be vested in a Board of five persons, of whom one shall be the Dean of Christ Church, two shall be nominated on the occasion of each election by the *Governing Body* of Christ Church, and two others shall be nominated in such manner as the University may from time to time by Statute determine. In default of any such Statute and subject thereto, such two persons shall be nominated on the occasion of each election by the Board of the Faculty of Natural Science.

10. Every Reader may, as an Official Student of Christ Church, be required to take such part in the educational work of the House as the *Governing Body* of the House shall from time to time determine: Provided that the work so required of him be specially connected with the Department of Science assigned to him as Reader and be not incompatible with the full performance of his duties for the University under this Statute.

WHEREAS the New *Governing Body* of Eton School, in virtue of the powers conferred upon them by "The Public Schools Act, 1868," did, on the thirteenth day of February, one thousand eight hundred and ninety-four, make a Statute altering Statutes I and XXIX of the existing Statutes of the School:

And whereas the said Statute has this day been laid before Her Majesty in Council, the same is published in the London Gazette in pursuance of the said Act:

And notice is hereby given, that it is lawful for

the bodies or persons authorized so to do in that Act, within two months from the date of the publication of this notification, to petition Her Majesty in Council to withhold Her approval from the whole or any part of such Statute.

Amendment of Statutes I and XXIX made by the new *Governing Body* of Eton School under the provisions of the Public Schools Act 1868 submitted by the said *Governing Body* for the approval of Her Majesty in Council.

Whereas by the Public Schools Act 1868 Section 11 the *Governing Body* of any School to which that Act applies is empowered from time to time to repeal or alter any Statute made in exercise of the powers of that Act, subject to certain conditions and restrictions therein specified. And whereas the said *Governing Body* of Eton School in exercise of the aforesaid powers made Statutes under the Heads of "The Constitution of the College" and "Retiring Pensions for Masters" numbered I and XXIX respectively. Number I being as follows "The Foundation of the College shall consist of a Provost and Ten Fellows a Head Master of the School and a Lower Master at least Seventy Scholars and not more than two Chaplains or Conducts." Number XXIX being as follows "It shall be lawful for the *Governing Body* to award Retiring Pensions to deserving Masters who shall have served as Head Master or for at least Fifteen years as Masters in the School but in special cases such length of service may be dispensed with by a vote in which at least two thirds of the *Governing Body* shall concur. Such Pensions shall not exceed Four hundred pounds per annum each nor Four thousand pounds per annum in the aggregate." Which Statutes were on the third day of November one thousand eight hundred and seventy-one approved by Her Majesty in Council. And whereas it was on the ninth day of May one thousand eight hundred and ninety-three resolved by the said *Governing Body* that it was expedient to alter Statutes No. I and No. XXIX being the Statutes hereinbefore particularly referred to and set out. Now therefore We the new *Governing Body* of Eton School do hereby alter the form and effect of the said Statutes and the said Statutes as altered by us will be in the terms following:—

Statute I as proposed to be amended:—

The Foundation of the College shall consist of a Provost a Vice Provost and a Bursar ten Fellows a Head Master of the School and a Lower Master at least Seventy Scholars and not more than two Chaplains or Conducts.

Statute XXIX as proposed to be amended:—

It shall be lawful for the *Governing Body* to award Retiring Pensions to deserving Masters who shall have served as Head Master, or for at least Fifteen years at Masters in the School, but in special cases such length of service may be dispensed with by a vote in which at least two thirds of the *Governing Body* shall concur. Such pensions shall not exceed Four hundred pounds per annum each. It shall be lawful for the *Governing Body* in each year or in any year to grant any sum in augmentation of any Retirement or Pension Fund for Assistant Masters established with the sanction of the *Governing Body*.
