GENERAL ORDER of the Local Government Board : Workhouse Regulations : Allowance of Tea, &c., to certain Paupers in the Workhouse :-

To the Guardians of the Poor of the several Unions and Separate Parishes in England and Wales ;-

And to all others whom it may concern.

WHEREAS by certain General and other

Orders the Poor Law Commissioners, the Poor Law Board, and the Local Government Board have made Rules and Regulations with regard to the government of the Workhouses of the said several Unions and Separate Parishes :

And whereas it is expedient that further provision should be made as hereinafter mentioned :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order that, from and after the date hereof, the following Regulations shall be in force in the said several Unions and Separate Parishes :-

ARTICLE I.-Notwithstanding anything contained in any of the Orders above referred to, the Guardians may, if they think fit, cause dry tea, with sugar and milk, to be supplied to such of the female inmates of the Workhouse as they may consider should be supplied with the same, the quantity to be allowed in each case, or in any class of cases, to be such as the Guardians may by Resolution prescribe.

- ARTICLE II.—In this Order, The word "Union" includes any Union of Parishes incorporated or united for the relief or maintenance of the Poor under any Act of Parliament;
- The term "Separate Parish." means a Parish or Place which is under a separate Board of Guardians;
- The word "Guardians" includes any Governors, Directors, Managers, Acting Guardians, Vestrymen, or other Officers appointed or entitled to act in the distribution or ordering of relief to the Poor from the Poor Rates under any Act of Parliament.
