BALTIC—SWEDISH SHORE.

Åhus—Admiralty Beacon not Available as a Landmark.

THE Swedish Government has given notice, dated 7th March, 1894, that Admiralty Beacon, northward of Åhus, is so hidden by wood that has grown up around it, that it cannot be seen from seaward, and therefore it will not be maintained.
