**NOTICE** is hereby given, that His Royal Highness The Prince of Wales will, by command of The Queen, hold a Levee at St. James's Palace, on behalf of Her Majesty, on Friday, the 29th instant, at three o'clock.

It is The Queen's pleasure that Presentations to His Royal Highness at the Levee shall be considered as equivalent to Presentations to Her Majesty.

#### REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEE TO BE HELD AT ST. JAMES'S PALACE, BY HIS ROYAL HIGHNESS THE PRINCE OF WALES, ON BEHALF OF HER MAJESTY.

*By Her Majesty's Command,*

Gentlemen who propose to attend Her Majesty's Levee, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

#### PRESENTATIONS.

Gentlemen who propose to present others must send in writing the name of such Gentlemen to the Lord Chamberlain's Office, not later than *two days* previous to the Levee, in order that the Lord Chamberlain may submit the names to Her Majesty, when, if they are approved, Presentation Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

It is particularly requested that the names of the Gentlemen to be presented be *very distinctly written* on the Presentation Cards delivered to the Lord Chamberlain at the Levee, in order that there may be no difficulty in announcing them to His Royal Highness.

The State Apartments will be open for the reception of Company coming to Court at half-past two o'clock.

THE Queen has been pleased by Letters Patent, dated the 7th instant, passed under the Great Seal of the United Kingdom, to make provision for the annexation to the Colony of the Cape of Good Hope of the British Possession of Pondoland, comprising the Territories of East and West Pondoland.

THE Queen has been pleased to grant unto George Fletcher Royds, of Pitmaston, in the county of Worcester, Gentleman, fourth and youngest son of Charles Smith Royds, Clerk, Rector of Haughton, in the county of Stafford, Prebendary of the Cathedral Church of Lichfield, by Mary Anne, his wife, eldest daughter of Francis Twemlow, late of Betley Court, in the county of Stafford, Esquire, by Elizabeth, his wife, daughter of Sir Thomas Fletcher, late of Betley Court aforesaid, Baronet, all deceased, Her Royal licence and authority that he and his issue may take and henceforth use the surnames of Fletcher-Twemlow instead of that of Royds, and that he and they may bear the arms of Twemlow and Fletcher quarterly with those of Royds; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
