#### ISLE OF WIGHT (SWINE-FEVER) ORDER OF 1894.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1893, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. No swine, fat or store, shall be moved into either of the Districts named in the Schedule to this Order from any place in England or Wales or Scotland: Provided that nothing in this Article shall be deemed to interfere with or apply to movement from any place in either of the Districts named in the Schedule to this Order to any other place in either of the said Districts.

2. The provisions of the England and Wales Markets and Fairs (Swine-Fever) Order of 1894 dated the thirteenth day of February, one thousand eight hundred and ninety-four shall not apply to either of the Districts named in the Schedule to this Order, and that Order shall be read and have effect as if the two Districts named in the Schedule to this Order were included in the Schedule to that Order as Districts to which that Order does not apply.

3. If a pig is moved in contravention of this Order the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and

the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Contagious Diseases (Animals) Act, 1878.

4. This Order shall take effect from and immediately after the nineteenth day of June, one thousand eight hundred and ninety-four.

5. This Order may be cited as THE ISLE OF WIGHT (SWINE-FEVER) ORDER OF 1894.
