THE Secretary of State hereby gives notice that he has certified the Buxion-Norfolk Industrial School for Boys, at Buxton Lamas, near Norwich, as fit to be an Industrial School for such Boys as may be sent there in pursuance of "The Industrial Schools Act, 1866," not exceeding sixty-five in number.

To the Vestry of the Parish of St. Peter and St. Paul, Hammersmith, and all whom it may concern.

WHEREAS by Section 15 of the London County Council (General Powers) Act, 1893, it is enacted that the London County Council may from time to time for the purpose of the elections of vestrymen, upon the application in writing of the vestry, or of not less than five hundred rated householders of a parish men-

tioned in Schedules A and B to the Metropolis Management Act, 1855, by order under their seal, rearrange the wards in such parish, and determine the number, extent, limits, and boundary lines of the new wards, but so nevertheless that no ward shall contain less than five hundred rated householders, and that the whole number of wards shall not exceed eight, and the Council shall, in making any such rearrangement, apportion among the several wards the number of vestrymen to be elected for such parish, and shall in assigning the number of vestrymen to each ward have regard, as far as practicable, as well to the number of persons rated to the relief of the poor in each ward as to the aggregate amount of the sums at which all such persons are rated, and the number of vestrymen assigned to each ward shall be a number divisible by three ; and it is also by the said Act enacted that such Order may contain such provisions with reference to the election, rotation, and retirement of vestrymen (whether elected prior or subsequently to the date of the Order) as the Council may think necessary for the purpose of carrying out the provisions of the Order.

And whereas under and by virtue of the provisions of the Metropolis Management Amendment Act, 1885, the parish of St. Peter and St. Paul, Hammersmith, is a parish mentioned in Schedule A to the Metropolis Management Act, 1855.

And whereas under and by virtue of the provisions of the said Metropolis Management Act, 1855, and of Section 41 of the Metropolis Management Amendment Act, 1862, the said parish was in the year one thousand eight hundred and seventy-three divided into three wards.

And whereas the Vestry of the said parish hath applied to the London County Council to rearrange the wards of the said parish, pursuant to the provisions of the said 15th section of the London County Council (General Powers) Act, 1893.

And whereas it appears from the rate books of the said parish, prepared in the month of October, one thousand eight hundred and ninetythree, that the said parish contains sixteen thousand and ninety-one rated householders, and that the rateable annual value of property in the said parish is five hundred and twenty-one thousand nine hundred and sixty-nine pounds.

Now the London County Council having considered the said application, and having taken into consideration the number of persons rated to the relief of the poor in each ward of the said parish and the aggregate amount of the sums at which all such persons are rated, and all the circumstances connected with such application, doth hereby order that the wards of the said parish of St. Peter and St. Paul, Hammersmith, be rearranged in manner following, that is to say, namely, that the said parish be divided into six instead of three wards, and that the six wards be distinguished by the numbers mentioned in the first column of the undermentioned Schedule; that the extent, limits, and boundary lines of such wards shall be those described in the second column of the said Schedule ; and that the number of vestrymen to be elected for each of the said wards shall be the number mentioned in the third column of the said Schedule, that is, seventy-two vestrymen.

And the London County Council doth further order that this Order shall come into force for the purpose of the first election of vestrymen under the Local Government Act, 1894, and such election shall be subject to the provisions of the said Act.
