THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1893, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

The Orders described in the Schedule to this Order to the extent described in that Schedule are hereby revoked: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the Orders hereby revoked, or either of them, before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Orders hereby revoked, or either of them, before the date of this revocation.
