Simpson, Her Majesty's surveying-vessel "Stork," of the existence of a sunken rock (1), with a depth of 18 feet on it, lying with Hagira Seuda bearing N.W. § W. (N. 49° W.), distant seven cables; and east extreme of Filfola Island S.S.W. & W. (S. 29° W.). The bank on which this rock is situated appears to be very rocky and uneven.

Approximate position, rock, lat. 35° 49′ 5″ N., long. 14° 25′ 45″ E.

Also, of the existence of a sunken rock (2), with a depth of nine feet on it, lying in St. Thomas Bay, with the centre of Mahsel Battery bearing N.W. § N. (N. 38° W.), distant  $2\frac{4}{10}$  cables; and St. Thomas Point Beacon N.E. (N. 45° E.).

St. Thomas Bay is foul and rocky.
