west partly by the district parish of the Holy Trinity Islington partly by the new parish of Saint Clement Barnsbury partly by the new parish of Saint James Lower Holloway and partly by the new parish of Saint Barnabas Hornseyroad all in the county and diocese aforesaid upon the north by the new parish of Saint Thomas Finsbury Park in the said county and diocese upon the north-east by the new parish of Christ Church Highbury in the same county and diocese upon the east partly by the new parish of Saint Augustine Highbury New Park and partly by the district parish of Saint Paul Ball's Pond both in the county and diocese aforesaid upon the south-east by the new parish of Saint Stephen Islington in the same county and diocese and upon the remaining side that is to say upon the south by an imaginary line commencing upon the boundary which divides the said new parish of Saint Stephen Islington from the parish of Saint Mary Islington aforesaid at the south-western corner of Canonbury-square and extending thence northward and in a direct line for a distance of twelve yards or thereabouts to a point at the middle of the eastern end of Canonbury-lane and extending westward along the middle of the said lane for a distance of six chains or thereabouts to its junction with Upper-street and with Parkstreet and continuing thence still westward along the middle of the last-named street for a distance of twelve chains or thereabouts to a point at its junction with Liverpool-road upon the boundary which divides the said parish of Saint Mary Islington from the district parish of the Holy Trinity Islington aforesaid."

And whereas drafts of the said scheme have in accordance with the provisions of the firstly hereinbefore mentioned Act, been transmitted to the patrons and to the incumbent of the said parish of Saint Mary Islington out of which it is intended that the district recommended in such scheme to be constituted shall be taken.

And whereas the said patrons and the said incumbent have offered certain objections to the said scheme.

And whereas (notwithstanding such objections) the said scheme has been approved by Her Majesty in Council: Now, therefore, Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-with registered by the Registrar of the said diocese of London. The QUEEN's Most Excellent Majesty in Council. WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four and of the Act of the thirtysecond and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the twenty-first day of June, in the

year one thousand eight hundred and ninety-four, in the words following, that is to say :-

"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four, of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of the Holy Trinity Bedford in the county of Bedford and in the diocese of Ely.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the twentysixth day of October in the year one thousand eight hundred and sixty and published in the London Gazette on the thirtieth day of the same month, a part of the parish of Saint Paul Bedford in the said county of Bedford and in the diocese of Ely aforesaid was assigned as a district chapelry to the consecrated church of the Holy Trinity situate within the limits of such parish and the same district was called 'The District Chapelry

of the Holy Trinity Bedford.'

"And whereas the said district chapelry of the Holy Trinity Bedford has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four become new a parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Your Majesty chapter thirtyseven and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four.

And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of the Holy Trinity Bedford should be altered in the manner

hereinafter mentioned.

"Now therefore with the consent of Honourable and Right Reverend Alwyne Bishop of the said diocese of Ely (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of the Holy Trinity Bedford shall be altered so that all that portion of the said new parish which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan here-unto appended and is thereon coloured pink shall be dissevered from such new parish and shall be restored to and shall in future again form part of the said parish of Saint Paul Bedford.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore-mentioned Acts or

any of them or of any other Act of Parliament.
