Arrivals from Black Sea Coast, between Russo-Roumanian frontier and Kertch, reduced to medical inspection with disinfection of passengers' clothes and linen at Cavak from August 14. Arrivals from Black Sea Coast, between Russo-Turkish frontier and Agha, subject to twenty-four hours' observation at Sinope or Cavak."
