W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twontieth years of Her Majesty chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the second day of August. in the year one thousand eight hundred and ninety-four, in the words following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Barnabas Dulwich situate within that part of the parish of Saint Giles Camberwell in the county of Surrey and in the diocese of Rochester, which comprises the village of Dulwich and which is isolated from the Mother Church.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Barnabas, Dulwich, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Randall Thomas Bishop of the said diocese of Rochester (testified by his having signed and sealed this representation) we the said Ecclesiastical Commissioners, humbly represent, that it would in our opinion be expedient that all that part of the said parish of Saint Giles Camberwell which is described in the schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church of Saint Barnabas Dulwich situate as aforesaid and that the same should be named 'The District Chapelry of Saint Barnabas Dulwich.'

"And with the like consent of the said Randall Thomas, Bishop of the said diocese of Rochester (testified as aforesaid), we the said Ecclesiastical Commissioners further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said church of Saint Barnabas Dulwich situate as aforesaid and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Reverend Frederick Frestus Kelly Clerk in Holy Orders the present Vicar or Incumbent of the vicarage of the said

parish of Saint Giles Camberwell shall continue to be such Vicar or Incumbent all the fees which may be received in respect of such publication solemnization or performance at the said Church of Saint Barnabas Dulwich situate as aforesaid shall be paid over by the minister thereof to the said Frederick Festus Kelly, and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

" The SCHEDULE to which the foregoing

Representation has reference : -

"The district chapelry of Saint Barnabas, Dulwich, being :--

"All that purt of the parish of Saint Giles. Camberwell, in the county of Surrey, and in the diocese of Rochester, wherein the present Incumbent of such parish still possesses the exclusive cure of souls, and which for all ecclesiastical purposes is an isolated portion of such parish, and comprises the village of Dulwich, all which part of the said parish is bounded upon all sides as follows, that is to say : upon the north, partly by the new parish of Saint Paul, Herne Hill, and partly by the new parish of Saint John the Evangelist, East Dulwich, both in the said county and diocese; upon the east, partly by the Consolidated Chapelry of Saint Clement, East Dulwich, and partly by the Particular District of Saint Peter, Dulwich Common, both in the county and diocese aforesaid; upon the south, by the new parish of Saint Stephen, South Dulwich, in the said county and diocese ; and upon the west, partly by the new parish of Emmanuel, West Dulwich, partly by the Particular District of Trinity, Tulse Hill, and partly by the new parish of Saint Jude, East Brixton, all in the county and diocese aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester. *C.
