mentioned and of the Act of the forty-eighth and forty-ninth years of Your Majesty chapter fiftyfive have prepared and now humbly lay before Your Majesty in Council the following scheme (1) for constituting a new archdeacoury within the diocese of Norwich to be called 'The Archdeaconry of Lynn' and for endowing the same in manner and to the extent hereinafter-mentioned and (2) for altering the boundaries of the existing archdeaconries of Norwich and of Norfolk respectively within the same diocese and for authorizing a certain further yearly payment to the archdeacon of the said archdeaconry of Norfolk.

"Whereas the said diocese of Norwich has hitherto comprised and now consists of three archdeaconries and no more to wit the said archdeaconry of Norwich the said archdeaconry of Norfolk and the archdeaconry of Suffolk. "And whereas the Right Reverend John

"And whereas the Right Reverend John Bishop of the said diocese of Norwich has proposed to us and has represented that it is in his opinion desirable that a new archdeaconry to be named the Archdeaconry of Lynn should be constituted within the said diocese of Norwich and should comprise and consist of certain portions of the said archdeaconries of Norwich and of Norfolk as described in the schedule to this scheme annexed and has also proposed to us that the two rural deaneries of South Repps and of Waxham should be transferred from the said archdeaconry of Norfolk to the said archdeaconry of Norwich and that the rural deanery of Breccles should be transferred from the last-named archdeaconry to the archdeaconry of Norfolk aforesaid.

"And whereas it appears to us that the fees which will accrue to the archdeacon of the Archdeaconry of Lynn as hereinafter proposed to be constituted will amount to a yearly sum of fiftyseven pounds and that a loss of a like yearly sum of fifty-seven pounds will result from the proposed arrangements to the archdeacon of the Archdeaconry of Norfolk.

"And whereas it appears to us to be expedient that the said proposals of the said Bishop should be carried into effect in manner hereinafter recommended and proposed.

"Now therefore with the consent of the said John Bishop of the said diocese of Norwich (in testimony of which consent he hath set his hand and his episcopal seal to this scheme) we the Ecclesiastical Commissioners for England humbly recommend and propose as follows that is to say

<sup>say</sup> "Firstly. As to the constitution and endowment of the said proposed archdeaconry of Lynn we recommend and propose that upon and from the day on which any Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order there shall be created within the said diocese of Norwich one new archdeaconry to be named ' the Archdeaconry of Lynn' to comprise and consist of those rural deaneries which are now portions of the said two archdeaconries of Norwich and of Norfolk respectively the names of which rural deaneries are set forth in numbered order under the name of the archdeaconry of Lynn in the said schedule to this scheme annexed.

"And we further recommend and propose that the rural deans and other the clergy and inhabitants of the said archdeaconry of Lynn shall be under and subject to the archidiaconal jurisdiction authority and control of the archdeacon of Lynn for the time being and that the said archdeacon of Lynn shall have and exercise all the rights powers

and duties of an archdeacon within the limits of his archdeaconry.

"And we further recommend and propose that we be authorized to pay yearly and every year out of the common fund created by the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen to the archdeacon of t'c said archdeaconry of Lynn hereinbefore recommended and proposed to be created and to his successors in the same archdeaconry the sum of one hundred and forty-three pounds per annum such yearly payment to be made upon the first day of January in every year in respect of the twelve calendar months ended that day.

" Provided always that the first payment so to be made by us as aforesaid shall be proportional to the period which shall have elapsed between the date of the institution of the first archdeacon of the said archdeaconry of Lynn and the first day of January next following the date of such institution and that every such yearly payment as aforesaid shall be apportionable between the archdeacon (or as the case may be the representatives of an archdeacon) who has resigned or otherwise avoided the said archdeaconry of Lynn on any day other than the first day of January in any year and the archdeacon who shall next thereafter be instituted to the same archdeaconry and that every such yearly payment shall be made by us only after we shall have been satisfied that the archdeacon on whose behalf application for such payment is made has during the previous year. complied with the conditions as to residence which at the date of such application are required by law

"Secondly. As to the proposed alteration of the boundaries of the two archdeaconries of Norwich and of Norfolk respectively we recommend and propose that upon and from the day on which any Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette the rural deanery of Breccles shall be transferred from the said archdeaconry of Norwich to the archdeaconry of Norfolk aforesaid and that upon and from the same day the rural deanery of South Repps and of the rural deanery of Waxham shall be transferred from the said archdeaconry of Norfolk to the archdeaconry of Norwich aforesaid so that the two archdeaconries of Norwich and Norfolk respectively shall comprise and consist of the rural deaneries which are set down in numbered order under the names of such two archdeaconrics respectively in the said schedule appended to this scheme.

"And we further recommend and propose that by way of compensation for the loss of income from fees which is hereinbefore-mentioned will be sustained by the archdeacon of the said archdeaconry of Norfolk we be authorized to pay yearly and every year out of our common fund aforesaid to the said archdeacon of Norfolk and to his successors the sum of fifty-seven pounds per annum in addition to the sums heretofore payable by us out of the same fund to the archdeacon of the said archdeaconry of Norfolk and upon the same terms and conditions as are applicable to the payment of the sums previously payable as aforesaid.

"And we further recommend and propose that nothing herein contained shall prevent us from hereafter recommending and proposing any other matter or thing relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.
