into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Hilda,

Millfield comprising :-

"(I) All that portion of the new parish (sometime district) of Saint Mark, Millfield, in the county of Durham and in the diocese of Durham which is bounded upon the north by the new parish of Saint Stephen Ayres Quay, in the said county and diocese upon the north east, upon the east, upon the south-east and upon the south by the parish of Bishop wearmouth, in the said county and diocese (including the hereinafter described portion thereof) and upon the remaining sides, that is to say, upon the west and upon the northwest by an imaginary line commencing upon the boundary which divides the said parish of Bishopwearmouth from the new parish of Saint Mark Millfield aforesaid, at the centre of the bridge which carries the Hetton Coal Company's line of railway over Chester-road, and extending thence first northward and then north-eastward along the middle of the said line of railway for a distance of thirty and one half chains or thereabouts to the point where it crosses Hylton-road near to the junction of such last-named road with Trimdonstreet, and extending thence eastward along the middle of the said Hylton-road for a distance of ten yards or thereabouts to the boundary which divides the said new parish of Saint Mark Millfield from the new parish of Saint Stephen Ayres Quay aforesaid.

(II) And also all that contiguous portion of the said parish of Bishopwearmouth which is bounded upon part of the south-east and upon the north by the above described portion of the new parish of Saint Mark, Millfield and upon the remaining sides, that is to say, upon the west and upon the remaining part of the southeast by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mark, Millfield from the parish of Bishopwearmouth aforesaid, at the firstly hereinbeforementioned point at the centre of the bridge which carries the said Hetton Coal Company's line of railway over Chester-road aforesaid and extending thence southward along the middle of the said line of railway for a distance of fifteen and one half chains or thereabouts to the centre of the bridge which carries such line of railway over the road or lane called or known as Lovers' Walk and which I ads from Eden House into Durhamroad and extending thence north-eastward along the middle of the said road or lane for a distance of two and one half chains or thereabouts to its junction with Durham-road aforesaid and extending thence north-eastward along the middle of the last-named road for a distance of eleven chains or thereabouts to a point at its junction with the roads called or known respectively as The Royalty and Western Hill upon the boundary which divides the said parish of Bishopwearmouth

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and

from the new parish of Saint Mark, Millfield aforesaid."

Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Durham.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four; and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four, duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the second day of August, in the year one thousand eight hundred and ninety-four, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Mark Wolverhampton and of the new parish of Saint Jude Wolverhampton both in the county of Stafford

and in the diocese of Lichfield.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the twenty-fifth day of February in the year one thousand eight hundred and forty-six and published in the London Gazette on the twenty-fourth day of March following a part of the parish of Wolverhampton in the said county of Stafford and in the said diocese of Lichfield was constituted a separate district for spiritual purposes and the same district was called 'The District of Saint Mark Wolverhampton.'

"And whereas the said district of Saint Mark Wolverhampton has under the provisions of the Act of the ninetcenth and twentieth years of Your Majesty chapter one hundred and four become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Your

Majesty chapter ninety-four.

"And whereas by the authority of another Order of Your Majesty in Council bearing date the seventh day of August in the year one thousand eight hundred and sixty-nine and published in the London Gazette ou the tenth day of the same month a part of the said new parish of Saint Mark Wolverhampton was assigned as a discrict chapelry to the consecrated church of Saint Jude situate within the limits of the same new parish and the same district chapelry was called 'The District Chapelry of Saint Jude Wolverhampton.'

"And whereas the said district chapelry of Saint Jude Wolverhampton has also become a new parish under the provisions of the lastly-

mentioned Acts.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries
