

Brighton as is contained within a line commencing from a point at the extreme south-eastern boundary of the county borough at low water mark thence in a northerly direction along the said boundary to the point of its intersection with the boundary of the parishes of Brighton and Preston at the north-eastern corner of the Tenantry Down, thence in a westerly direction along the said parochial boundary to the north-western corner of the Tenantry Down, thence in a southerly direction across Bearhill-road to the north-eastern corner of the Brighton and Preston Cemetery wall, thence in a southerly direction along the said wall to the south-eastern corner of the said cemetery, thence in a southerly direction for a distance of forty-seven linear feet to a point in the centre of Elm-grove, thence in a southerly direction to the south-eastern end of the boundary wall of the Brighton Workhouse, thence in a southerly direction along the wall enclosing the reservoir of the Brighton Waterworks to its south-eastern end, thence to the nearest point in the centre of Freshfield-road, thence in a south-westerly direction along the centre of Freshfield-road to a point opposite to the centre of Evelyn-terrace, thence in an easterly direction along the centre of Evelyn-terrace to a point in the centre of Sutherland-road, thence in a southerly direction along the centre of Sutherland-road to a point opposite to the centre of College-terrace, thence in an easterly direction along the centre of College-terrace to a point in the centre of Walpole-terrace, thence in a southerly direction along the centre of Walpole-terrace to a point opposite to the centre of Walpole-road, thence in a westerly and southerly direction along the centre of Walpole-road, to a point in the centre of Eastern-road, thence in a southerly direction to and along the centre of College-place to a point in the centre of St. George's-road, thence in a westerly and southerly direction along the centre of Bloomsbury-place to the centre of Marine-parade, thence in a southerly direction to the boundary of the county borough thence in an easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 2 otherwise Queen's Park Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the western boundary of Ward No. 1, with the boundary of the county borough at low-water mark, thence in a northerly direction along the said boundary to the point in the centre of Elm-grove aforesaid, thence in a westerly direction along the centre of Elm-grove to a point opposite to the centre of Queen's Park-road, thence along the centre of Queen's Park-road to a point opposite to the centre of Upper Park-place thence in an easterly direction to and along the centre of Park Hill to a point in the centre of Park-street, thence in a southerly direction along the centre of Park-street to a point in the centre of Eastern-road, thence in a southerly direction to and along the centre of Lavender-street, to the centre of Upper Saint James'-street, thence in a southerly direction to and along the centre of Grafton-street to the centre of the Marine-parade, thence in a southerly direction to the boundary of the county borough, and thence in an easterly direction to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 3 otherwise 'Pier Ward' shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from

the point of intersection of the western boundary of Ward No. 2 and the boundary of the county borough at low-water mark, thence in a northerly and westerly direction along the said boundary (of Ward No. 2) to a point opposite to the centre of Upper Park-place, thence in a southerly direction to and along the centre of Upper Park-place to a point in the centre of Carlton Hill, thence in a westerly direction along the centre of Carlton Hill to the centre of the Grand Parade, thence in a southerly direction along the centre of the Grand Parade to a point opposite to the centre of Edward-street, thence in a southerly direction to and along the centre of Pavilion Parade and the centre of the road abutting upon the eastern side of the Old Steine enclosures to a point opposite to the centre of Saint James'-street, thence along the centre of the last-mentioned road to the centre of the Marine Parade, thence in a southerly direction across the Grand Junction-road to the boundary of the county borough, thence in an easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 4 otherwise Pavilion Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the western boundary of Ward No. 3 with the boundary of the county borough at low-water mark, thence in a northerly direction along the said western boundary of Ward No. 3 to a point opposite to the centre of Church-street, thence in a westerly direction to and along the centre of Church-street to the centre of Queen's-road, thence in a southerly direction along the centre of Queen's-road to the centre of North-street, thence in a southerly direction to and along the centre of West-street to the centre of King's-road, thence in a southerly direction to the boundary of the county borough, thence in an easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 5 otherwise Regency Ward shall comprise so much of the area of the county borough of Brighton as is contained within a line commencing from the point of intersection of the western boundary of Ward No. 4 and the boundary of the county borough at low-water mark, thence in a northerly direction along the said western boundary of Ward No. 4 to the centre of North-street, thence in a north-westerly direction along the centre of North-street to Upper North-street, thence to and along the centre of Upper North-street to the centre of Dyke-road, thence along the centre of Dyke-road to a point opposite to the centre of Clifton Hill, thence in a north-westerly direction to and along the centre of Clifton Hill to a point opposite to the centre of Powis-road, thence in a southerly direction to and along the centre of Powis-road to the centre of Victoria-road, thence to and along the centre of Montpelier-street to a point opposite to the centre of Upper North-street, thence to and along the centre of Hampton-place to the centre of Western-road, thence in an easterly direction along the centre of Western-road to a point opposite to the centre of Preston-street, thence in a southerly direction to and along the centre of Preston-street to the centre of King's-road, thence in a southerly direction to the boundary of the county borough, and thence in an easterly direction along the said boundary to the point of commencement aforesaid.

"And I do hereby determine that Ward No. 6 otherwise West Ward shall comprise so much of
