ORDER of the Local Government Board making certain Orders applicable to new Unions:—

Malton and Norton Out-Relief Unions.

To the Guardians of the Poor of the Malton Out-Relief Union, in the County of the North Riding of Yorkshire;

To the Guardians of the Poor of the Norton Out-Relief Union, in the County of the East Riding of Yorkshire;—

To the Overseers of the Poor of the several Parishes comprised in the said Unions;—

And to all others whom it may concern.

WHEREAS under "The North and East Ridings of Yorkshire (Malton) Confirmation Order, 1894," the Poor Law Union of Malton will from and after the appointed day as defined by Section 84 of the Local Government Act, 1894, for the purpose of out-door relief, and all purposes other than the purposes mentioned in the said Order and for which the said Union will continue to be one Union, be divided into two Poor Law Unions; namely,—

The Malton Union consisting of the Parishes of Airyholme-with-Howthorp, Amotherby, Appleton-le-Street, Barton-le-Street, Barton-le-Willows, Brawby, Broughton, Bulmer, Butterwick, Coneysthorpe, Crambe, Foston, Fryton, Ganthorpe, Habton Great, Habton Little, Henderskelfe, Hildenley, Holme South, Hovingham, Huttons Ambo, Malton New St. Leonards, Malton New St. Michael, Malton Old, Ryton, Scackleton, Sheriff Hutton-with-Cornborough, Slingsby, Sitttenham, Swinton, Terrington-with-Wiganthorpe, Thornton-le-Clay, Wath, Welburn, and Whitwell-on-the-Hill; and

The Norton Union, consisting of the Parishes of Acklam, Birdsall, Burythorpe, Duggleby, Eddlethorpe, Firby, Grimston North, Heselton East, Heselton West, Howsham, Kenneythorpe, Kirby Grindalythe, Kirkham, Knapton, Langton, Leavening, Leppington, Menneythorpe, Norton and Welham, Raisethorpe and Burdale, Rillington, Scagglethorpe, Scampston, Settrington, Thirkleby, Thorpe Bassett, Westow, Wharram-le-Street, Wharram Percy, Wintringham, and Yedingham.

And whereas it is expedient that the provisions of certain Orders issued from time to time by the Poor Law Commissioners, the Poor Law Board, and by Us, should be made applicable to and be in force in the said Malton and Norton Out-Relief Unions:

Now We, the Local Government Board, hereby Order as follows:—

On and after the twenty-eighth day of December, one thousand eight hundred and ninety-four, the provisions of the General and other Orders in force in the Malton Union, shall, subject to the provisions of the Local Government Act, 1894, apply to and be in force in the said Malton and Norton Out-Relief Unions in so far as such provisions relate to the matters for the purpose of which the said Out-Relief Unions are constituted
