Company of Glasgow, and such conveyance of animals by that vessel is hereby prohibited accordingly.

Offences.

2. If an animal is conveyed in contravention of the provisions of this Order, the owner and the charterer and the master of the vessel shall, each according to and in respect of his own acts. be deemed guilty of an offence against the Act of

#### Interpretation.

3. In this Order-

The Act of 1894 means the Diseases of Animals Act, 1894:

Animals means cattle, sheep, goats, and swine: Master includes a person having the charge or command of the vessel:

Other terms have the same meaning as in the Act of 1894.

#### Commencement and Duration.

4. This Order shall come into operation on the first day of February, one thousand eight hundred and ninety-five, and shall cease to operate from and immediately after the thirty-first day of January, one thousand eight hundred and ninety six.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Act, 1894, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

### Prohibition of Movement of Animals into certain Lairs.

1. Animals shall not be moved into the lairs or premises described in the Schedule to this Order.

Offences.

2. If an animal is moved into the said lairs or premises in contravention of this Order, the occupier of such lairs or premises, and the owner of the animal, and the person for the time being in charge thereof, and the person moving, directing, or permitting the movement, and the consignee or other person receiving or keeping the animal knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts or defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Interpretation.

3. Terms in this Order have the same meaning as in the Diseases of Animals Act, 1894.

## Commencement.

4. This Order shall come into operation on the tenth day of January, one thousand eight hundred and ninety-five.
