In order to secure payment of his debts in full the debtor will assign to the Official Receiver the equity of redemption in the policy of insurance on his life for £500 effected in the Scottish Provident Institution, which policy is now held by the office to secure the payment of a loan thereon of £105, the premium on such policy, together with the interest on the said loan, to be paid by the Official Receiver out of the said allocation of salary. Preferential debts to be paid out of the amount to be received by the Official Receiver under the terms of this Scheme. Provision for payment of all proper costs, charges, expenses, fees, and percentages is provided for by deposit of the required amount with the Official Receiver, with the exception of the costs of the Petitioning Creditor's solicitors, which are to be paid out of the first available moneys coming to the hands of the Official Receiver under this Scheme. Upon payment of his debts in full, with interest thereon, the aforesaid policy of assurance or the equity of redemption therein, to be re-assigned to or vested in the debtor by the Official Receiver. A Composition of 7s. 6d. in the pound shall be paid on all provable debts within ten days after confirmation of the proposal by the Court, two of the debtor's unsecured creditors, whose debts amount to £4,659 0s. 10d. and £1,026 4s. 3d. respectively, having consented to withdraw their claims and release the debtor therefrom. Payment of the Composition secured by deposit of the sum required in cash with the Official Receiver within one week before the day appointed for hearing the application to confirm the Scheme. All proper costs, charges, and expenses of and incidental to the proceedings, and all fees and percentages payable to the Official Receiver and the Board of Trade to be paid in full. Composition of 10s. in the pound on all provable debts to be secured by payment to the Official Receiver out of his salary as an Accountant in the employ of the Alliance Marine and General Assurance Company Limited of such a sum as shall be sufficient to pay the same. The said sum to be paid within a period of three years, and the same shall be paid by 36 equal monthly payments, the first of such monthly payments to be paid on or within three days of 24th of January, and all subsequent instalments on or within three days of the 24th day of each subsequent month.
