MAURITIUS AND SEYCHELLES.

IN pursuance of the Rules Publication Act, 1893, Her Majesty's Postmaster-General hereby gives notice that a Warrant dated the 22nd day of June 1895 has been made on his representation by the Commissioners of Her Majesty's Treasury in pursuance of the Post Office Acts, ordering, directing and declaring that on and from the first day of July one thousand eight hundred and ninety-five, parcels may, subject to the provisions of the said Warrant, and at the rates of postage therein specified, and in accordance with the regulations therein contained, be transmitted by post between the United Kingdom and Mauritius and the Seychelles Islands.
